DAVID E. BUDDE, being first duly sworn on oath, deposes and says that:

Introduction

1. I am the District Attorney Chief Investigator. I submit this Affidavit to assist the John Doe judge in the above-encaptioned proceeding.
2. I incorporate by reference my statement concerning my qualifications as set forth in prior Affidavits submitted to the court in the John Doe investigation.
3. I incorporate by reference all of the Applications, Affidavits and other papers that have been submitted to the court in these John Doe proceedings, especially those papers as noted in the paragraphs that follow.
4. Detailed below, I have discovered evidence that Tim Russell was engaged in political activity on multiple occasions over a sustained period of time while he was working as an employee in the Office of the Milwaukee County Executive and while he was working as an Administrator for the Department of Health and Human Services (DHHS). I make this Affidavit principally to search and seize records and information in the form of digital evidence contained on computer workstations issued by Milwaukee County for Tim Russell's use.

PREMISES TO BE SEARCHED

5. Based upon information I have received from Mary Ann Grimes of the Corporation Counsel's Office, which in turn was based on Milwaukee County Department of Administration records, I know that Tim Russell worked as the Deputy Chief of Staff in the Office of the County Executive from January 26, 2009 through March 14, 2010. The County Executive's Office is located on the 3rd Floor of the Milwaukee County Courthouse, 901 North 9th Street, Milwaukee, Wisconsin.

6. Based upon my visits to the County Executive's Office in the Milwaukee County Courthouse, including visits for the purpose of taking Darlene Wink's county computer and other office documents, pursuant to process issued in these proceedings, I know that the computer equipment in question is located within an office contained inside a suite of rooms labeled as "306," the County Executive Offices.

7. Milwaukee County maintains records as to the computer equipment it maintains for the benefit of its employees. I am advised by Milwaukee County Information Management Services Division employee Angela Buesing, that prior to March 14, 2010, Mr. Russell was assigned the use of a computer workstation described as a Lenovo desktop computer with a serial number 1S8816AJLKBNVY6 and an Asset Tag number of 260353. Records currently indicate that the computer is located in the County Executive's Offices in the Courthouse. It is, according to Ms. Buessing's records, currently used by Charlesanne Wilson.

8. After March 14, 2010, Russell worked as an Administrator at DHHS. Based on investigation by Investigator James Thomas, I am informed that Tim Russell's office is located in the Marcia P. Coggs Human Services Center, 1220 West Vliet Street. A photo of the front entrance to the Coggs Center is attached as Exhibit K. Russell's office is located in a suite of offices on the third floor of the building. That suite of offices is located in an area with a glass door entryway having the writing "*Director's Office*" on the glass. Based upon information I have received from Corporation Counsel Mary Ann Grimes, which in turn was based on information she obtained from County records, Mr. Russell is assigned an office in Room 301.

9. I am advised by Milwaukee County Information Management Services Division employee Angela Buesing that Mr. Russell is currently assigned the use of a computer workstation described as a Lenovo desktop computer with a serial number LKAZLMP and an Asset Tag number of 271015. IMSD record reflect that this computer is located at the Marcia Coggs Human Service Center, 1220 West Vliet Street, Milwaukee, Wisconsin in Room 301.

10. I request that the court authorize a search of these office suites for the purpose of locating these computer workstations.

OBJECTS OF THE SEARCH

11. This affidavit seeks permission to search for all records and information relating to violations of sections 946.12, 11.36 and 11.61 of the Wisconsin Statutes, viz., Misconduct in Public Office and Political Solicitation involving Public Officials and Employees for the time period since January 1, 2009 relating directly or indirectly to political activity while on duty as a County employee.

12. As used in this Affidavit, the terms "records" and "information" to include all items of evidence in computerized, digital form by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks, jump drives, thumb drives, CDs, DVDs, external USB drives, 3.5" disks or other media that can store data).

13. I anticipate that the primary source of records and information to be seized will be in the form of computer workstations. As a matter of personal experience and common sense, however, I also anticipate that, in the area surrounding the target computer that Mr. Russell currently uses, there will be other forms of digital evidence of the type described above, i.e., such as hard disks, jump drives, thumb drives, CDs, DVDs, external USB drives, 3.5" disks and other electronic media that can store data. Therefore, for the purpose of seizing this type of evidence, I ask that the court authorize a search of the office space within which Mr. Russell's current computer is located.

PROBABLE CAUSE – MISCONDUCT IN PUBLIC OFFICE & UNLAWFUL ACTIVITY BY PUBLIC EMPLOYEE

Tim Russell's Partisan Political Activities During Work Hours

14. I know that conducting political activity from government offices is a matter of Misconduct in Public Office in violation of Wis. Stats. §946.12(2).¹ It is also a potential direct and/or Party to a Crime violation of Wis. Stats. §11.36(2).²

¹ Wis. Stats. §946.12(2) provides "No employee may, "[i]n the officer's or employee's capacity as such officer or employee, do[] an act which the officer or employee knows is in excess of the officer's or employee's lawful authority or which the officer or employee knows the officer or employee is forbidden by law to do in the officer's or employee's official capacity.")

² Wis. Stats. §11.36(2) provides "No person may . . . receive from any . . . employee of a political subdivision of this state any contribution or service for any political purpose during established hours of employment or while the officer or employee is engaged in his or her official duties.")

15. I also know that misconduct is defined as conduct that is inconsistent with the duties of one's office, *State v. Schultz*, 306 Wis.2d 598, 743 N.W.2d 823 (App. 2007), and many sources, such as employee handbooks as well as official e-mail and memos, can be used to determine duties associated with an office. *State v. Jensen*, 272 Wis.2d 707, 681 N.W.2d 230 (App. 2004). As relevant to this case, however, the Code of Ethics for Milwaukee County is published as part of the County Ordinances and Section 9.06 expressly prohibits political campaigning by County employees.³ Likewise, the County Technology Use policy prohibits the use of County computer equipment for political campaign activities.

16. The John Doe judge previously authorized a \$968.375 Search Warrant for the Google GMail account of timrussellwi@gmail.com. Records in connection with that warrant were delivered to the Milwaukee County District Attorney's Office on August 18, 2010.

17. The following table summarizes e-mails, attached as Exhibits A to J, which I have examined from among those obtained through the execution of this Gmail search warrant. All of these e-mails were sent by either timrussellwi@gmail.com (Exhibits A to E, G to J) or Tim.Russell@milwcnty.com (Exhibit F).⁴ These e-mails demonstrate partisan political activity during periods of time when Russell was acting as a Milwaukee County employee. This statement (concerning Russell's status as a Milwaukee County employee) is based upon my review of Russell's Ceridian time sheets that indicate that he was working as a Milwaukee County employee on the dates and times specified in the table below.

³ Section 9.06 of the County Ordinances entitled "Political Activity" provides:

(1) CAMPAIGN PROHIBITIONS: No county public official or employee at his or her place of employment while engaged in his or her official duties shall, for the apparent purpose of seeking to elect or defeat a person seeking elective office:

- (a) Wear or display any campaign material.
- (b) Distribute any campaign literature.
- (c) Solicit contributions for any candidate.
- (d) Engage in political campaign activities for any candidate.
- (e) Circulate nomination papers for elected office.

18. I respectfully submit that this summary of e-mails demonstrates probable cause to establish that Russell committed Misconduct in Public Office and Unlawful Activity by a Public Employee. I note that the table represents a summary of only those e-mails I have thus far closely examined. The table is not a complete list of the partisan political e-mail activity I have seen in Russell's e-mails.

PROBABLE CAUSE TO BELIEVE THESE ITEMS ARE EVIDENCE OF A CRIME AND WILL BE FOUND OF THE PREMISES

19. I respectfully submit that a search of the computers described above will likely produce records and information productive to this investigation in that Russell's Milwaukee County desktop computer is likely to contain documentary evidence relating to the partisan political work believed to have been completed on "county time."

> COMPUTERS AND ELECTRONIC STORAGE

20. I believe there is good cause to believe that records stored in an electronic format will be found within the Russell computers and peripherals. I am aware that a significant number of partisan political communications were exchanged through electronic mail. Based on the return of the Google GMail Search Warrant and based on my general understanding of GMail, I know that Tim Russell's Gmail e-mail account is a web-based e-mail account that can be accessed anywhere there is access to the Internet, including the Milwaukee County offices wherein Tim Russell worked and works. District Attorney's Office IT Manager Jim Krueger indicates⁵ that if a computer or electronic medium is found within these offices, there is good reason to believe relevant records will be stored in that computer or electronic medium, for at least the following reasons, all of which have been articulated in earlier filings and which I summarize here:

- a. Remnants of computer files can be recovered months or even years after they have been downloaded onto a hard drive, deleted or viewed via the Internet.

⁵ I base the technical statements in this next section of my Affidavit on my review of Jim Krueger's Affidavits of June 28, 2010 and July 1, 2010. I note that the Krueger Affidavits themselves incorporate by reference the Affidavit of June 24, 2010 submitted by the Division of Criminal Investigation forensic computer expert, Brad Montgomery. I also incorporate that Affidavit herein by reference.

Electronic files downloaded to a hard drive can be stored for years at little or no cost. Even when files have been deleted, they can be recovered months or years later using readily available forensics tools.

b. Therefore, deleted files, or remnants of deleted files, may reside in free space or slack space - that is, in space on the hard drive that is not currently being used by an active file - for long periods of time before they are overwritten. In addition, a computer's operating system may also keep a record of deleted data in a "swap" or "recovery" file.

c. Similarly, files that have been viewed via the Internet are typically automatically downloaded into a temporary Internet directory or "cache." The browser often maintains a fixed amount of hard drive space devoted to these files, and the files are only overwritten as they are replaced with more recently viewed Internet pages or if a user takes steps to delete them.

21. As set forth in the Affidavits previously filed by computer forensic experts Jim Krueger and Brad Montgomery, I know that searching for information stored in computers often requires agents to seize most or all electronic storage devices to be searched later by a qualified computer expert in a laboratory or other controlled environment. This is often necessary to ensure the accuracy and completeness of such data, and to prevent the loss of the data either from accidental or intentional destruction. Additionally, to properly examine those storage devices in a laboratory setting, it is often necessary that some computer equipment, peripherals, instructions, and software be seized and examined in the laboratory setting. This is true because of the following:

a. The volume of evidence. Computer storage devices (like hard disks or CD-ROMs) can store the equivalent of millions of pages of information. Additionally, a person may try to conceal criminal evidence; he or she might store it in random order with deceptive file names. This may require a forensic investigator to peruse all the stored data to determine which particular files are evidence or instrumentalities of crime. This sorting process can take weeks or months, depending on the volume of data stored, and it would be impractical and invasive to attempt this kind of data search on-site.

b. Technical requirements. Searching computer systems for criminal evidence

sometimes requires highly technical processes requiring expert skill and a properly controlled environment. The vast array of computer hardware and software available requires even computer experts to specialize in some systems and applications, so it is difficult to know before a search which expert is qualified to analyze the system and its data. In any event, however, data search protocols are exacting scientific procedures designed to protect the integrity of the evidence and to recover even "hidden," erased, compressed, password-protected, or encrypted files. Because computer evidence is vulnerable to inadvertent or intentional modification or destruction (both from external sources or from destructive code imbedded in the system as a "booby trap"), a controlled environment may be necessary to complete an accurate analysis.

22. In light of these concerns, I request the Court's permission to seize the computer hardware (and associated peripherals) that are believed to contain some or all of the evidence described in the warrant, and to conduct an off-site search of the hardware for the evidence described, if, upon arriving at the scene, the agents executing the search conclude that it would be impractical to search the computer hardware on-site for this evidence.

> NETWORK

23. I know that Milwaukee County operates a networked computer system whereby individual computers (usually referred to as workstations) are connected to central computer (usually called a file server). User data can exist on both the workstation and the file server. In Milwaukee County, e-mail is managed on a central file server using Lotus' Notes software. In such circumstances, evidence is potentially discoverable on both the workstations and the servers. However, this search is principally concerned with evidence in the form of computers and peripheral devices; the John Doe judge has already, on August 19, 2010, issued a Subpoena Duces Tecum to the Milwaukee County Information Management Services for network based-evidence.


CONCLUSION

Parkway delay angers officials Cudahy, St. Francis mayors say GOP move threatens development

Political and business leaders in Cudahy and St. Francis

were angered Monday by Assembly GOP budget recommendations that included a one-year delay in completing the long-awaited Lake Parkway.

Characterizing the parkway as a key to economic development, they said some area businesses already had made important decisions as a result of promises made by Gov. Tommy Thompson and other state officials. "I don't think it speaks well for the present administration or the Republican leadership of the Legislature," Cudahy Mayor Raymond Glowacki said. "I believe the moneys are there. This Lake Parkway isn't something that has come out of the blue sky in the last couple of years.

"I really felt that the coming of the parkway could be an absolute renaissance for the southeastern part of the county. We have had businesses that have expanded on the promise of the Lake Parkway. For us to take a hit such as this, I really believe this is not good for Milwaukee, St. Francis or Cudahy."

The parkway would link downtown Milwaukee with the southeastern suburbs by carrying traffic from the southern end of the Hoan Bridge to E. Layton Ave. Plans to widen Pennsylvania Ave. south of Layton also would be delayed as part of a budget proposal worked out last week by members of the Republican caucus, according to Rep. Scott Walker (R-Wauwatosa). Details of the plan were released Monday.

Walker said caucus members were aware of the economic impact of their decision on the two communities but had to weigh other considerations. A major decision was that they had few options for saving money and could not delay major road work on the Interstate 94 east-west corridor more than one year. Any longer delay in that project would have forced the state to put weight restrictions on trucks

using the **Zoo Interchange**, he said.

The Lake Parkway was among the projects selected for a delay primarily because it was not on the Department of Transportation's long-term transportation and safety list, **Walker** said. The east-west corridor involved safety concerns as well as significant economic ramifications, he noted.

Work on the 3.5-mile parkway has been under way for some time. Contracts for two other major parts of the project the parkway interchanges at Howard Ave. and Carferry Drive will be awarded this week using money in the current budget,

transportation officials said. When those are awarded, nearly half of the project's estimated \$110 million cost will have been spent.

Existing plans call for the parkway to be completed by late 1998. So far, the project is on schedule, according to Tom Longtin, the Transportation Department's project manager, and his supervisor, Ron Felsner.

Because of inflation, each year the project is delayed will add about 3% to the remaining costs, Felsner and Longtin said.

A year's delay also would jeopardize a one-year agreement, effective July 1, between local railroads over shared use of track leading to the Port of Milwaukee. It took five years for the state to get the competing railroads to agree to share track while portions of track are torn up and rerouted for the parkway. The railroads use track for access to the port and for assembling freight trains.

An Area Cut Off

David Stawski, president of the St. Francis Association of Commerce, said the parkway would help provide better access to the southeastern part of the county, which has suffered because of a lack of major north-south and east-west links with Milwaukee and the freeway. He found any delay troubling.

"This project is critical to us," Stawski said. "In my opinion, this project was signed, sealed and delivered, and now has become something of a political football.

Transit projects a good use of funds

Nick Rudelich's June 11 letter to The Morning Mail shows that he has a short and limited memory when it comes to transportation funding. Originally, \$241 million of federal funds was set aside for use on the East-West Corridor. Specifically, the money could be used for a light rail system along the corridor or for the widening of I-94 to insert car pool and bus lanes.

During debate over a locally preferred alternative last May, leaders in Milwaukee County pushed a plan including a multimillion-dollar light rail system, while leaders in Waukesha County pushed for freeway lanes that would have eaten into residential and commercial property in Milwaukee County.

At that time, a group of Milwaukee County lawmakers objected to both proposals.

Fast forward to May 1998. The same Milwaukee County lawmakers -- three Democrats and three Republicans -- applauded the change in the use of the \$241 million and asked that the funds be used on local projects, including the reconstruction of the Marquette Interchange, the **Zoo Interchange** and on expanding support for the Milwaukee County Transit System.

In our opinion, supporting these projects is a better use of the funds and will ultimately save Milwaukee County taxpayers money.

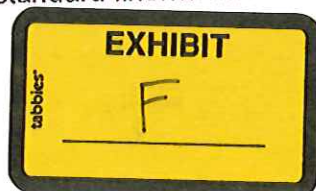
