Showing probable cause that on today's date in the County of Milwaukee, there is now located and concealed in and upon certain premises, located within the City of Milwaukee in said County, and more particularly described as follows:

DESCRIBE PREMISES:

Premises having a street address of Room 306, Milwaukee County Courthouse, 901 North 9th Street, Milwaukee, Wisconsin, the Milwaukee County Executive suite of offices. It is more particularly described as the Office of the Milwaukee County Executive offices located on the third floor of the Milwaukee County Courthouse. It is located behind a glass door through which the words "Offices of the County Executive" can be seen on the eastern wall of the reception area. A sign reading "County Executive 306" appears to the north of the glass door. See Exhibits A & B attached hereto. And this search shall extend to all offices, rooms and enclosures within the Offices of the County Executive and shall include certain goods, chattels and property, to-wit:

DESCRIBE OBJECTS OF SEARCH:

All records and information relating to violations of Wisconsin Statutes §§946.12, 11.36 and 11.61 since January 1, 2009, in any form relating directly or indirectly to political activity in violation of said statutes and involving:

Thomas Nardelli
Fran McLaughlin
Dorothy Moore
Tim Russell and
Darlene Wink.

The terms "records" and "information" include all items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks or other media that can store data); any handmade form (such as writing, drawing, painting); any mechanical form (such as printing or typing); and any photographic form (such as microfilm, microfiche, prints, slides, negatives, videotapes, motion pictures, photocopies).

The term "political activity" means campaign activities, the making or soliciting of campaign contributions, fundraising, and/or lobby activities.

This warrant authorizes the seizure of all wireless networking devices.

This warrant authorizes a forensic search of all information and records after seizure.

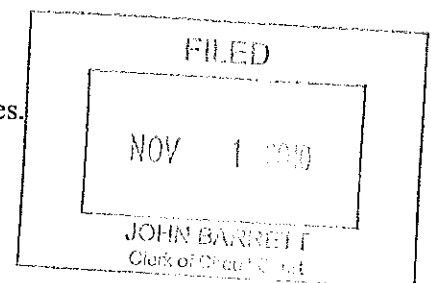
Which objects constitute evidence of the commission of a crime, to wit;

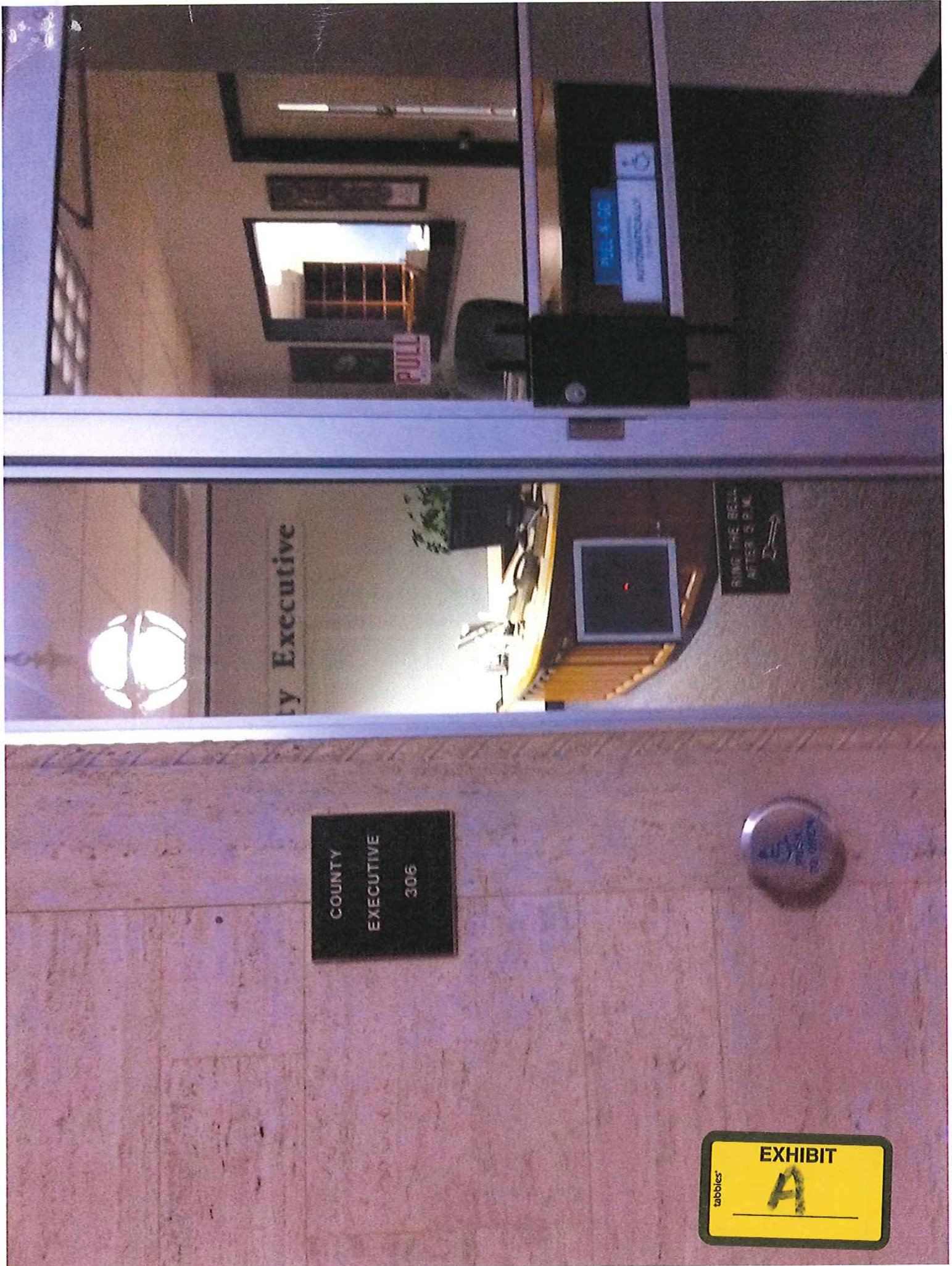
