# **CURRENT RESEARCH**

I am presently working on an analysis of Beaumont's portrait of America, drawn from his novel, *Marie*. I have recently written two articles about *Marie*, focusing particularly on Beaumont's understanding of the tyranny of the majority and the limits of equality as seen through the problem of racial prejudice; these articles will be appear in anthologies to be published in the United States and Spain later this year.

I have also recently returned from a Study Leave, during which time I engaged in an intensive reading program of the early 19<sup>th</sup> century French thinkers who influenced Alexis de Tocqueville.

My readings focused on Tocqueville himself as well as on François Guizot, Pierre-Paul Royer-Collard, Charles de Rémusat, and Benjamin Constant. I was especially interested in their treatments of democracy (as both a social state and a political system), of individualism, and of history.

Other views from ancient, modern, and contemporary philosophy are examined as possible alternatives to each question brought forth in Lincoln.
