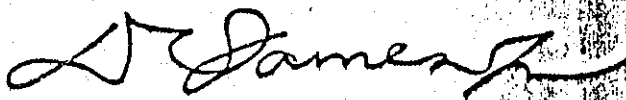
We have received your inquiry regarding the tax exempt status of Amateur Athletic Union of the U. S.
