Dear Ms. Hintz:

I have reviewed the application submitted by the **Northwest Catholic School Association** for inclusion in the United States Conference of Catholic Bishops group tax exemption ("Group Ruling") and listing in the **2010** edition of the Official Catholic Directory ("OCD"). Based upon the application and supporting documentation, **Northwest Catholic School Association** has been approved for inclusion in the Group Ruling and listing in the OCD under the Archdiocese of Milwaukee.

This letter establishes **Northwest Catholic School Association's** exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code ("Code") in the interim until publication of the **2010** OCD. **Northwest Catholic School Association** has qualified as a public charity under the provisions of the Code checked below:


